Councilman LeBlanc read into the record a letter that was email to him by a constituent in his district. Councilman LeBlanc asked Planning and Zoning Assistant, Calesia Anderson to collect data regarding the U-Turns that are currently allowed on Hwy. 64 and report back by September 10, 2024.

City of Zachary Attorney, John Hopewell, spoke to Mayor McDavid and council members regarding the public cemetery. Mr. Hopewell explained that Act 450 does not address aesthetics. It only addresses a municipal political subdivision's use of labor & resources to abate a public health or safety risk of an abandoned cemetery when the cemetery is located within the jurisdiction of the municipality. It only allows the political subdivision to do so when a majority of governing authority finds that the conditions in the abandoned cemetery present a public health or safety risk and that such abatement constitutes a public purpose. Mr. Hopewell directs that "abandoned cemetery" shall have the meaning ascribed to it in LSA -R.S. 25:933, which means it is no longer being used for interments, not maintained in good condition, and has fallen into a state of disrepair. Act 450, upon the advice and consent of the City council cannot do much more than it has been doing.
